Board of Directors Minutes

Meeting brought to order at 5:00 PM

- I. Guest Presentations
 - 1. Allen Alchian Paul Commemoration

Alchian requested Board approval for further research to placing a "memorial" for past and present residents who have contributed to the King's Deer community. The unfortunate passing of Rich Paul and the extent to which he contributed to this community brought to light that the Community should appropriately recognize all contributions. Alchian and other volunteers will come back to the Board and present plans, finances, and locations for final approval.

2. Jeff Daily presented the idea of his magazine becoming the "official" newsletter for KD. Snelling requested answers to how he would separate the advertising from the HOA news since the possible perception is that the HOA is recommending these advertisers and trying to make a profit. The Board members made no decision on the request.

III. Directors' Reports

A. Common Area Maintenance

Snelling reported that this year the fountain will remain in the pond. Also, damage has occurred on the path in front of 19869 Kershaw Court, the homeowner is being held accountable and must correct the situation by January 8, 2015.

- B. Covenant Enforcement Oversight Committee

Carlson moved to approve the continued meeting of the CEOC on the 1st Thursday 3:00 PM of each Month.. Grace Highhouse, Al Walter, Allen Alchian, and Vern Kuykendall have also been officially approved by the Board of Directors. Motion seconded and approved unanimously.

- C. Architectural Control Committee
 - 1. ACC Report

Snelling stated that there were 11 new construction projects approved and 1 denied for the year 2014. 127 projects total including new construction have been reviewed by the ACC.

- Meeting Schedule for 2015
 Snelling requested that the ACC continue their meetings on the 2nd & 4th Thursday 5:00 PM of each month except November/December which will have one meeting on the 2nd Thursday.
- 3. Approval of committee members Allen Alchian, John Witsken, George Panoncillo, Vern Kuykendall, Tom Haddan, and Dan Snelling are the members approved by Board at this time.
- 4. 19846 Kershaw Court, Lot 35 Highlands filing 4 maintenance Complaints from neighbors about the house because it looks abandoned, as a courtesy the ACC members visited the property and took pictures for the lot file. Snelling requested the Board members consider this property a covenant violation under the "nuisance" clause of the Covenants. (*Para. # 18. NUISANCE: Owners shall maintain their Lots in a clean, attractive condition.....*)The homeowner will be sent a letter with a description of the areas of concern with the notation that if the areas of concern are not corrected within a reasonable period of time that a Covenant enforcement action may be instigated.
- 5. DSG variety changes Snelling indicated that the ACC in the year 2015 was going to review the DSG and make changes for the betterment of the Community.
- D. NEPCO -

Darrell Glenn, County Commissioner was the speaker. Aguilar reported that the County will be asphalting Archers Drive from Kings Deer Point to Highway 105 this also includes the cul-de-sacs Caspian and Lancers Court. They are still processing a major upgrade to Hwy 105 which

will become a four-lane in 2016. Next meeting a representative from the El Paso County Assessors' office will be the speaker.

E. Neighborhood Watch

Haddan the Neighborhood Watch Coordinator is still trying to recruit a block captain for the area close to Prairie Winds Elementary School. It has been quiet since the King's Deer residents helped locate and catch the burglars this summer.

Carlson met with Alchian for information update.
