**ANNUAL MEETING** •••••• KD annual meeting was held Nov 16, 2004. It was well attended. Main subjects were hiring of Warren Management Group to administer the association and the election of officers. A good report on common area maintenance and pond renovation was received. Owners were urged to submit property modifications to the ACC, to be mindful of covenants and to connect with one another to strengthen the Neighborhood Watch effort. Financially, the association is solvent and able to comfortably meet its financial obligations. Notice that the annual assessment has gone up to \$180 per annum.

**DIRECTORS** Continuing directors are Chuck Hoffmann, Mary Fortey and Dan Potter. Newly elected directors are Dan Rivers who continues as President of the HOA, Joe Blackburn, Steve Anderson and Bob Morgan. Allen Alchian continues as Chair of the Architectural Control Committee.

**FIRE** On November 13, 2004, the Prejean family residence at 19315 Bardsley Place caught fire and was nearly destroyed. The cause was attributed to a faulty gas fireplace. The official report says the fire was due to "holes in the flue pipe that allowed hot gases to escape which ignited nearby combustibles". The fireplace was a "Heat 'n Glow" brand; model "PICR – TRC". Suggestions have been made that we check the installation of our fireplaces and that we consider placing a smoke detector in the attic, which is where the Prejean fire was primarily located..

Questions have surfaced about the management of the fire, timeliness of the response, availability of water and so on. We are assured by the Fire Authority that all of these issues are being addressed and where necessary, corrective action is being taken.

TRI – LAKES FIRE PROTECTION DISTRICT ••••• After many years of trying, the Tri-Lakes Fire Protection District and the Woodmoor – Monument Fire Protection District have merged. Our fire protection and emergency medical response is now provided through the Tri – Lakes Monument Fire Rescue Authority. The three fire stations serving our area ,,,,, Hwy 105 by the bowling alley, the former Woodmoor station on Woodmoor Drive and the new station at Roller Coaster and Hwy 105 comprise the Authority. There are no more artificial boundaries between districts and all medical response and ambulance service is provided by the Authority. A new ambulance and a new fire engine have been added to the Authority's inventory of equipment

**SNOW** ••••• We need the moisture but it surely can be heavy at times. Removal services are Rick Evelo at the Golf Club, 481-1570; Greg Bois Vert, 233-4227; Tony Verico, 481-3380; Jon Newby, 487-0399. Please be advised that snow fences are not authorized by the covenants. Terminology ...... "Winter Storm Watch" = a winter storm is possible.

- "Winter Storm Warning" = a winter storm is occurring or will soon occur.
- "Blizzard Warning" = sustainable winds or gusts of 35mph and considerable falling snow reducing visibility to less than 1/4 mile to prevail 3 hours or longer.

**COVENANT ENFORCEMENT** ••••••• Be advised that the Warren Management team has taken over this duty for the association. Their staff will cruise the sub-division and report violations to the HOA Board who will then act on the observations reported. Please remember that the process includes a series of notices when an infraction is identified, the end result possibly a fine and a lien against the property. Nobody wants these issues to go that far, of course. Confrontation is not the objective here but a reasonable and timely resolution is. As always, the owner's cooperation is greatly appreciated.

**TREES** •••••• Many KD lots have *lots* of trees. It's a good thing to thin the trees and remove ones from close in proximity to houses to improve fire safety. Diseased trees are to be removed per covenant article 14. Watch your trees for evidence of infection. Infected trees die from the top down usually in May/June and quickly ... one or two weeks. If you have questions, call the tree monitor at 488-8808. Remember ..... the county has the authority to require an owner to remove infected trees. The county Forest Ranger gets a search warrant, confirms the presence of pine beetle infestation, then the court orders the owner to remove the tree(s). If the owner fails to comply, the county may remove the tree(s) and charge the owner the cost.

**TREE REMOVAL** ••••• There are a number of tree removal services available. Check first with Rick Evelo at the KD golf Club ..... 481-1570. Others are .... Tree Man @ 488-1818; A-C Trees @ 719-661-1536; Tree Master @ 481-0101; Tri – Lakes Timber Management @ 481-2331.

Likewise ..... we want you to report any problem situations to your Block Captain ASAP so he/she can alert your neighbors. Please connect with your Block Captain to facilitate this request.

**POND** •••• Gazebo pond is repaired .... liner is down. Some cosmetic grading / landscaping will happen in the spring. When to golf course charges its irrigation system mid-March, the pond will be filled.

**MULCH** ••••• Got mulch ????? Free mulch is available to all KD owners. It's located on a vacant lot at the corner of Castlecomb and Queen's Crescent accessed via a dirt drive off Queen's Crescent. Good source of material for your spring gardening and landscaping projects .Just a reminder ... if you do a major change to your landscaping or are landscaping a new property, you need to submit your plan to the Architectural Control Committee for their review.
